The following policy reference the coordination of communication intelligence liaison in London is announced:

1. A Senior Liaison Officer for STANCIB (hereinafter designated as "SLO") is appointed and accredited to the London Sigint Centre. He will represent the Board and its members vis a vis the London Sigint Centre on all matters pertaining to communication intelligence.

2. The duties and responsibilities of the SLO are herewith defined:

- (a) He will represent STANCIB at the London Sigint Centre, will supervise and expedite all routine activities pertaining to British-U. S. liaison relating to communication intelligence, and will make full and regular reports concerning them to STANCIB via the Coordinator.
- (b) He will have jurisdiction over the activities and personnel in Great Britain of the STANCIB Liaison Group in so far as STANCIB matters are concerned. He will direct such personnel, and will determine and delimit such activities, in accordance with policy communicated to him by STANCIB via the Coordinator.
- (c) STANCIB members may obtain freely through the Liaison Group such communication intelligence and technical matters pertaining thereto as may be required by them where such collection and exchange involves no conflict with STANCIB policy. After liaison has been established, direct communication between working groups may be authorized by the STANCIB Coordinator. Nothing contained herein is intended to limit other intelligence activities outside the scope of communication intelligence. There will be no unilateral activity concerning communication intelligence.
- (d) The general liaison policy of all personnel dealing with communication intelligence in Great Britain will be determined by STANCIB, whose

Coordinator will instruct the SLO accordingly. No STANCIB liaison personnel in Great Britain, however, shall be considered exempt from such guidance as the SLO may deem necessary.

- (e) The SLO will review the intentions and the credentials of any U. S. citizen desiring to have contact or dealings with the London Sigint Centre, and will define the scope of such activities in accordance with the instructions of the STANCIB Coordinator.
- (f) STANCIB will arrange through appropriate channels, that the SLO and his staff be afforded all necessary facilities in London, such as space, communications channels, and equipment. Such arrangements will be made as will afford the SLO, his activities, and his working areas, the maximum security in order that there might be no compromise of communication intelligence matters.
- (g) The SLO and those persons under his jurisdiction in STANCIB liaison activities will normally be attached to the American Embassy, London, as assistant military, assistant naval or special attaches. This attachment is for administrative purposes. In all respects except administrative, the SLO and his staff are directly responsible to STANCIB in Washington with regard to all STANCIB liaison activities.

The following Policy Reference the Coordination of Communication Intelligence Liaison in London is announced:

1. A Senior Liaison Officer for STANCIB (hereinafter designated as "SLO") is appointed and accredited to the London SIGINT Centre. He will represent the Board and its Members vis a vis the London ~~Sigint~~ SIGINT Centre on all matters pertaining to Communication Intelligence.

2. The Duties and Responsibilities of the SLO are herewith defined:

(A) He will represent STANCIB at the London SIGINT Centre, will supervise and expedite all routine activities pertaining to British-U.S. Liaison relating to Communication Intelligence, and will make full and regular reports concerning them to STANCIB via the Coordinator.

(B) He will have jurisdiction over the Activities and Personnel in Great Britain of the STANCIB Liaison Group in so far as STANCIB Matters are concerned. He will direct such personnel, and will determine and delimit such activities, in accordance with policy communicated to him by STANCIB via the Coordinator.

(C) STANCIB Members may obtain freely through the Liaison Group such Communication Intelligence and Technical Matters pertaining thereto as may be required by them where such collection and exchange involves no conflict with STANCIB Policy. After Liaison has been established, direct Communication between Working Groups may be authorized by the STANCIB Coordinator. Nothing contained herein is intended to limit other Intelligence Activities outside the scope of Communication Intelligence. There will be no Unilateral Activity concerning Communication Intelligence.

(D) The General Liaison Policy of all Personnel dealing with Communication Intelligence in Great Britain will be determined by STANCIB, whose Coordinator will instruct the SLO accordingly. No STANCIB Liaison Personnel in Great Britain, however, shall be considered exempt from such guidance as the SLO may deem necessary.

(E) The SLO will review the intentions and the credentials of any U. S. Citizen desiring to have contact or dealings with the London SIGINT Centre, and will define the scope of such activities in accordance with the instructions of the STANCIB Coordinator.

Subject: Establishment of an United States Combined
Intelligence Liaison Center in Great Britain

1. It is now recognized that a single liaison agency to supervise and unify the various U.S. communications intelligence and related activities in Great Britain is urgently necessary. Such agency would effectively represent and conform with the functions of the new Authority in Washington known as STANCIB, and its scope would be delimited thereby. It would come directly under the jurisdiction of the STANCIB Coordinator, would work with equal emphasis in the interests of the various U.S. Government departments which compose STANCIB, and would present in Great Britain, both practically and figuratively, the single common purpose for which STANCIB was created.
2. It should be borne in mind that such representation of U.S. intelligence agencies in Great Britain would occupy a special position quite distinct and separate from the usual relationship of Intelligence to Command; and it would act in a particular sphere where collection and exchange of communications intelligence is inseparably linked with the collection and exchange of certain other forms of intelligence. In order to bring about such unified representation, it is felt that the members of STANCIB should pool their affairs in Great Britain exactly as they have agreed to pool them in Washington, and that the STANCIB Coordinator must have the advantage of carrying out his intentions with respect to

corresponding British Agencies through the instrument of a single London representative. This paper is concerned with a modus operandi for such unified representation, for which a suggested charter follows:

a) A Senior Liaison Officer for STANCIB (hereafter designated as "S.L.O.") is appointed and accredited to the London SIGINT Centre. He will represent the combined Intelligence interests of the U.S. Authorities which compose STANCIB, namely, the State Department, the War Department, the Navy Department, and the Department of Justice (F.B.I.). These Authorities, insofar as they deal with STANCIB matters, will act in concert and will maintain no representation in Great Britain independent from that afforded by the S.L.O. above named.

b) The jurisdiction of the S.L.O. is herewith defined:

(1) He will present STANCIB policy to the London SIGINT Board, will supervise and expedite all routine activities pertaining to this phase of Anglo-American relationships, and will make full and regular reports concerning them to the STANCIB Coordinator.

(2) He will have jurisdiction over the activities and personnel in Great Britain of the member Authorities of STANCIB where they are concerned with communications intelligence or with related

atters. He will direct such personnel, and will determine and delimit such activities, in accordance with policy communicated to him by the STANCIA Coordinator.

(3) In the field of Communications Intelligence per se, his control of personnel assigned to duty in Great Britain by STANCIA will be operational and direct. In the field of collection and exchange of intelligence, communications or otherwise, his control will be identical but with the following modification; provision will be made to allow liaison agents (normally under the jurisdiction of the S.L.O.) of member Authorities of STANCIA to obtain freely such intelligence as may be from time to time required of them by their respective Chiefs of Bureau, where such collection and exchange clearly involves no conflict with the collection and exchange of communications intelligence, and with the proviso that the S.L.O. is promptly and fully advised of such unilateral activities and their results.

(4) The general liaison policy and the working program of all personnel assigned by STANCIA to duty in Great Britain will be determined by STANCIA, whose Coordinator will instruct the S.L.O. accordingly. No STANCIA liaison personnel in Great Britain, however, shall be considered exempt from such allocation or

guidance as the S.L.C. may deem necessary.

(5) It will be the right and the duty of the S.L.C. to review the intentions and the credentials of any U.S. citizen desiring to have contact or dealings with the London SIGINT Centre, and to define the scope of such activities or to prohibit them, in accordance with the instructions of the STANCIB Coordinator.

(6) Whether the appointed S.L.C. be an Army or a Navy officer, or a civilian, it is directed, as arranged by STANCIB through appropriate channels, that he and his staff be afforded all facilities in London, such as space, communications channels, and equipment, by the U.S. military or civilian Authority in Great Britain designated to act for STANCIB in this capacity. It is further directed that this designated Authority accord to the S.L.C., his activities, and his working spaces, the right of freedom from questioning, inspection, or any other form of censorship.

(7) The S.L.C. and those persons under his jurisdiction in STANCIB liaison activities will normally be attached to the American Embassy, London, as assistant military and / or naval attachés, or, if civilians, as special attachés, but it is understood that said attachment is necessary for administrative and practical purposes only. In all respects except
